Pursuant to Articles 13, c. 2, letter c), 14, c. 2, letter d), 15 et seq. of the General Data Protection Regulation - Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data (hereinafter referred to as "GDPR"), we hereby provide you with information regarding the exercise of your rights relating the personal data provided to allow the relationship with Cereal Docks Food S.r.l.

The exercise of these rights is subject to the limits, rules and procedures laid down by the GDPR. The interested party must know them and implement them. Furthermore, in accordance with the provisions of article 12, paragraph 3, the Controller shall provide the interested party with information relating to the action taken without undue delay and, in any case, no later than one month after receipt of the request. This period may be extended by two months, if necessary, taking into account the complexity and number of requests. The Data Controller shall inform the data subject of such extension, and of the reasons for the delay, within one month of receipt of the request.

The Controller reserves the right to charge a fee in the event of manifestly unfounded or excessive (even repetitive) requests.

The exercise of right is free of charge. However, if the Controller has reasonable doubts as to the identity of the natural person making the present request, he may request further information necessary to confirm the identity of the person concerned.

I am informed that the data indicated in this form are used exclusively to provide feedback to requests and will be kept for 5 years, in order to ensure proper proof of the procedure, for any exercise of rights in administrative or judicial proceedings.
