



Right to be forgotten (art. 17)	You have the right to obtain from the Controller the erasure of personal data concerning you if the personal data are no longer necessary with respect to the purposes for which they were collected or otherwise processed. Right to restriction of treatment (art. 18)	You have the right to obtain from the data Controller the restriction of the processing when you have complained about the accuracy of the personal data (for the period necessary for the data Controller to verify the accuracy of such personal data) or when the processing is unlawful, but you oppose the erasure of personal data and instead request that they be restricted in their use or when the data are necessary for the establishment, exercise or defense of a right in court, while the Controller does not need them anymore. The exercise of these rights is subject to the limits, rules and procedures laid down by the GDPR. The data subject must know them and implement them. Furthermore, in accordance with the provisions of article 12, paragraph 3, the Controller shall provide the data subject with information relating to the action taken without undue delay and, in any event, no later than one month after receipt of the request. This period may be extended by two further months, if necessary, taking into account the complexity and number of the requests. The Controller shall inform the data subject of such extension, and of the reasons for the delay, within one month of receipt of the request.

The Controller reserves the right to charge a fee in the event of manifestly unfounded or excessive (even repetitive) requests.

The exercise of right is free of charge. However, if the Controller has reasonable doubts as to the identity of the natural person making the present request, he may request the provision of additional information necessary to confirm the identity of the data subject.

I am informed that the data indicated in this form are used exclusively to provide feedback to requests and will be kept for 5 years, in order to ensure proper proof of the procedure, for any exercise of rights in administrative or judicial proceedings.
